

## REPAIR WARRANTY POLICY

SCR CONTROLS, INC. WARRANTS TO THE CUSTOMER WHO HAS EQUIPMENT REPAIRED:

THE PARTS REPAIRED OR REPLACED SHALL BE FREE OF DEFECTS IN MATERIAL AND WORKMANSHIP FOR ONE (1) YEAR FROM THE DATE OF REPAIR.

IF THE REPAIRED EQUIPMENT FAILS AS OUTLINED ABOVE THEN THE CUSTOMER SHOULD CONTACT SCR CONTROLS TO OBTAIN A "RETURN MATERIAL AUTHORIZATION" (RMA), PREPARE THE EQUIPMENT FOR SHIPMENT AND RETURN THE GOODS TO SCR CONTROLS.

CUSTOMER WILL BEAR ALL COSTS OF TRANSPORTATION TO AND FROM SCR CONTROLS FACILITY, RISK OF LOSS FOR GOODS NOT AT SCR'S FACILITY AND ANY COST REQUIRED TO REMOVE OR PREPARE THE GOODS FOR SHIPMENT TO THE REPAIR FACILITY, AND TO REINSTALL EQUIPMENT SUBSEQUENT TO REPAIR.

## IF A DEFECT EXISTS, AT ITS OPTION SCR CONTROLS WILL:

(1) REPAIR THE EQUIPMENT AT NO CHARGE; (2) EXCHANGE THE EQUIPMENT WITH A PRODUCT THAT IS NEW OR WHICH HAS BEEN MANUFACTURED FROM NEW OR SERVICEABLE USED PARTS AND IS AT LEAST FUNCTIONALLY EQUIVALENT TO THE ORIGINAL EQUIPMENT OR; (3) REFUND THE REPAIR PRICE FOR THE EQUIPMENT.

THIS WARRANTY IS EFFECTIVE ONLY IF WRITTEN NOTIFICATION OF ANY CLAIM UNDER THIS WARRANTY IS RECEIVED BY SCR CONTROLS AT THE ADDRESS INDICATED ABOVE WITHIN THIRTY (30) DAYS FROM RECOGNITION OF DEFECT BY THE CUSTOMER.

THE ABOVE INDICATES THE FULL EXTENT OF SCR CONTROLS LIABILITY UNDER THIS WARRANTY. SCR CONTROLS SPECIFICALLY DISCLAIMS ANY LIABILITY FOR: (A) DAMAGE OR FAILURE DUE TO IMPROPER USE OR INSTALLATION; (B) DAMAGES IN SHIPMENT; (C) DAMAGE OR FAILURE DUE TO ABNORMAL OPERATION, CONDITIONS OF LOAD, TEMPERATURE, ALTITUDE OR ATMOSPHERE WHETHER INTENTIONAL OR UNINTENTIONAL; (D) NON-AUTHORIZED SERVICE, REPAIR, MODIFICATION, INSPECTIONS, REMOVAL, TRANSPORTATION OR INSTALLATION; (E) MISAPPLICATION OR MISUSE; OR, (F) CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE, OPERATION OR MAINTENANCE OF THE EQUIPMENT.

THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, WHICH EXTEND BEYOND THAT DESCRIBED HEREIN. SCR CONTROLS SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OF GOODS OR OF THE FITNESS OF THE GOODS FOR ANY PURPOSE.

SCR CONTROLS NEITHER ASSUMES NOR AUTHORIZES ANY REPRESENTATIVE OR ANY OTHER PERSON TO ASSUME FOR SCR CONTROLS ANY OTHER LIABILITY IN CONNECTION WITH THE REPAIR OR SHIPMENT OF SCR CONTROLS GOODS. SCR CONTROLS RESERVES THE RIGHT TO MAKE CHANGES AND IMPROVEMENTS IN REPAIRS AND SERVICES WITHOUT INCURRING ANY OBLIGATION TO SIMILARLY PURCHASED REPAIRS AND SERVICES.
